- 1. Respondent shall have the neutralizer systems installed and fully operational in the Republic Transfer Stations by September 30, 2017.
- 2. Respondent shall have the odor neutralizer installed and fully operational on the working face equipment by June 30, 2017.
- 3. Respondent shall install 150 new and/or replacement wells by July 31, 2017.
- Respondent shall install the 30 pumps needed on existing wells by April 15, 2017.
- 5. Of the 150 new and replacement wells mentioned above, Respondent shall install any necessary pumps on those wells by August 31, 2017.

Additionally, the Conditions as set forth in the Findings and Decision dated March 14, 2017 remain in full force and effect.

Failure to comply in full with any and all conditions and increments of progress may result in modification or revocation of this order by the Hearing Board, and/or enforcement actions by the SCAQMD.


