BACKGROUND ON THE WAIRE PROGRAM

- Rule 2305 Warehouse Indirect Source Rule (ISR) Warehouse Actions and Investments to Reduce Emissions (WAIRE) Program adopted May 2021
- Indirect source rule to reduce emissions and facilitate emission reductions from warehouse activities
- Rule 2305 includes reporting requirements for owners and operators of new and existing warehouses ≥100,000 sq ft
 - Warehouse Owners
 - Warehouse Operations Notification (WON) report
 - Warehouse Operators
 - Initial Site Information Report (ISIR)
 - Annual WAIRE Report (AWR)
 - Actions taken and/or investments made to fulfill annual compliance obligations

PUBLIC ACCESS TO FACILITY INFORMATION

South Coast AQMD-regulated facilities

- Many warehouses are newly regulated by South Coast AQMD under Rule 2305
- Public information may be requested from existing and identifiable records
 - California Public Records Act
 - Exemptions apply
- Existing online FIND tool provides easy access to individual facility information from various South Coast AQMD records and data sources
 - WAIRE program data will be included in FIND



FACILITY SEARCH USING F.I.N.D. MAP



*Warehouse Operations Notification is the only required reporting obligation for warehouse owners under Rule 2305

**Or within 14 days of operator change or 30 days after renovation that changes the square footage

***If the warehouse operator vacates the warehouse during the compliance period the AWR is due the date the operator leaves

WAREHOUSE OPERATIONS NOTIFICATION (WON) REPORT REQUIRED INFORMATION

- ♦ All owners of warehouses \geq 100,000 sq ft must submit a WON report
- Information required for initial WON Report submission includes:
 - Warehouse building
 - Address and size
 - Legal Owner
 - Contact information (Address, phone number, and email)
 - Warehouse lessee(s) / sublessee(s) leasing at least 50,000 sq ft
 - Contact information (Address, phone number, and email)
 - Lease terms (Square footage leased and lease start/end dates)
 - Square footage that may be used for warehousing activities
 - Immediate prior lessee(s) since May 7, 2021

Used for WAIRE Program outreach to potential warehouse operators subject to Rule 2305

INITIAL SITE INFORMATION REPORT (ISIR) REPORT REQUIRED INFORMATION

- All applicable warehouse operators must submit a one-time ISIR report
- Information required for one-time Initial Site Information Report submission includes:
 - Warehouse size and space used for warehousing activities
 - Number of truck trips in the previous 12- month period
 - Number of truck trips anticipated during the compliance period for which the upcoming AWR must be submitted
 - Anticipated actions to meet the WPCO for the current compliance period
 - Details on the following potential onsite equipment:
 - owned or leased truck fleet, onsite alternative fueling stations, yard trucks, and onsite energy generation systems (e.g., solar)

ANNUAL WAIRE REPORT (AWR) REPORT REQUIRED INFORMATION

- All applicable warehouse operators must submit an Annual WAIRE Report
- Information required for Annual WAIRE Report submission includes:
 - Number of actual truck trips during the compliance period
 - Number of WAIRE Points earned from the following:
 - WAIRE Menu actions
 - Approved Custom WAIRE Plan
 - Mitigation fee
 - Transferred WAIRE Points

No emission data – Staff will use reported information to estimate emission reductions achieved program-wide, but not for individual warehouses

Current contact information for the warehouse operator (Address, phone number, and email)

WAIRE REPORTS RECEIVED TO DATE

WON Reports were due from warehouse owners by September 1,2021

- Received 646 submissions accounting for 2,556 warehouse buildings
 - Staff currently reviewing, processing, and analyzing data
 - Rulemaking analysis identified up to ~3,300 warehouses. Additional analysis underway to determine why buildings are unreported. Staff will conduct appropriate follow-up to ensure all reports are submitted.
 - Example analysis: Preliminary results shows that 30 out of estimated 45 large owners* submitted WON reports, representing ~1/3rd of all warehouses


