

## NOTICE OF PUBLIC HEARING

PROPOSED ADOPTION OF, OR AMENDMENT TO, THE RULES AND REGULATIONS  
OF THE SOUTH COAST AIR QUALITY MANAGEMENT DISTRICT

**RE: Proposed Amended Rule 1180 – Fenceline and Community Air Monitoring for  
Petroleum Refineries and Related Facilities  
and  
Proposed Rule 1180.1 – Fenceline and Community Air Monitoring for Other Refineries**

**NOTICE IS HEREBY GIVEN** that a public hearing on the matter of adoption of rules and regulations for the South Coast Air Quality Management District (South Coast AQMD), or the amendments thereto, will be held **at 9:00 a.m. on Friday, January 5, 2024 in the Dr. William A. Burke Auditorium at South Coast AQMD, 21865 Copley Drive, Diamond Bar, CA 91765**, at which time evidence will be taken and all interested persons will be heard by the South Coast AQMD Governing Board. The meeting will be conducted through a hybrid format of in-person and/or virtual attendance via videoconferencing and by telephone with opportunities for public comment. **NOTICE IS FURTHER GIVEN** that the South Coast AQMD is considering the adoption of Proposed Amended Rule 1180 – Fenceline and Community Air Monitoring for Petroleum Refineries and Related Facilities (PAR 1180) and Proposed Rule 1180.1 – Fenceline and Community Air Monitoring for Other Refineries (PR 1180.1). The objective of PAR 1180 and PR 1180.1 is to address a lawsuit filed against South Coast AQMD (Los Angeles Superior Court, Case No. 22STCP04398) relative to exempting refineries with capacities less than 40,000 barrels per day and incorporate other updates. PAR 1180 will require air monitoring by additional facilities, monitoring of additional air pollutants identified in the Office of Environmental Health Hazard Assessment report, “Analysis of Refinery Chemical Emissions and Health Effects,” finalized in March 2019 (OEHHA report), conducting a root cause analysis when air pollutants are detected above a notification threshold, and independent-party audits of monitoring systems. PAR 1180 will also update definitions and clarify rule language. PR 1180.1 will establish fenceline and community air monitoring requirements similar to PAR 1180 for smaller refineries that are not currently subject to PAR 1180. In addition, South Coast AQMD will consider adopting Rule 1180 and Rule 1180.1 Fenceline Air Monitoring Plan Guidelines, which detail what is needed to complete a fenceline monitoring plan.

**NOTICE IS FURTHER GIVEN** that PAR 1180 and PR 1180.1 will not be submitted for inclusion into the State Implementation Plan.

**NOTICE IS FURTHER GIVEN** that a written analysis pursuant to Health and Safety Code Section 40727.2 has been prepared that identifies all existing state and federal air pollution control requirements, all existing and proposed South Coast AQMD rules and regulations, and all pollution control requirements and guidelines that apply to the same equipment or source type as PAR 1180 and PR 1180.1 proposed for amendment and adoption.

**NOTICE IS FURTHER GIVEN** that pursuant to California Environmental Quality Act (CEQA) Guidelines Sections 15002(k) and 15061, the proposed project (PAR 1180 and PR 1180.1) is exempt from CEQA pursuant to CEQA Guidelines Sections 15061(b)(3) and 15306. Further, there is no substantial evidence indicating that any of the exceptions in CEQA Guidelines Section 15300.2 apply to the proposed project. A Notice of Exemption will be prepared pursuant to CEQA Guidelines Section 15062, and if the proposed project is approved, the Notice of Exemption will be filed for posting with the State Clearinghouse of the Governor's Office of Planning and Research, and with the county clerks of Los Angeles, Orange, Riverside, and San Bernardino Counties.
