I am very concerned about the Refinery Committee's overturn of the Board's direction:

On June 22, the Refinery Committee voted 3-2 to overturn the Board's previous direction by restricting Staff to bringing back only one of the Board's previously directed options — an MOU, and we would add a severely flawed MOU with a much weaker Performance Standard than all previous iterations brought forward by Staff to the Board and inconsistent with all previously submitted staff recommendations.

I think it is imperative that Rule 1410 be adopted but with the enhanced mitigation and implementing a phase-out of MHF within 4 years.
