

NOTICE OF PUBLIC HEARING

PROPOSED ADOPTION OF, OR AMENDMENT TO, THE RULES AND REGULATIONS OF THE
SOUTH COAST AIR QUALITY MANAGEMENT DISTRICT
AND PROPOSED SUBMISSION INTO THE STATE IMPLEMENTATION PLAN

RE: Proposed Amended Rule 1147 – NO_x Reductions from Miscellaneous Sources

NOTICE IS HEREBY GIVEN that a public hearing on the matter of adoption of rules and regulations for the South Coast Air Quality Management District (South Coast AQMD), or the amendments thereto, will be held on **Friday, April 1, 2022** in the Dr. William A. Burke Auditorium at South Coast AQMD, 21865 Copley Drive, Diamond Bar, CA 91765, at 9:00 a.m., at which time evidence will be taken and all interested persons will be heard by the South Coast AQMD Board. The meeting could be conducted either all virtual or through a hybrid format of in-person/virtual attendance via videoconferencing and by telephone with opportunities for public comment, so please refer to the instructions on the South Coast AQMD's website for information regarding the format of the Public Hearing and details on how to participate: <http://www.aqmd.gov/home/news-events/meeting-agendas-minutes>.

NOTICE IS FURTHER GIVEN that the South Coast AQMD is considering the adoption of Proposed Amended Rule 1147 (PAR 1147). The air quality objective is to reduce nitrogen oxide (NO_x) emissions and limit carbon monoxide emissions from miscellaneous combustion equipment that require a South Coast AQMD permit with a unit heat rating $\geq 325,000$ BTU/hour at REgional CLean Air Incentives Market (RECLAIM), former RECLAIM, and non-RECLAIM facilities. PAR 1147 updates NO_x emission limits and establishes a new carbon monoxide limit for applicable equipment categories to reflect current BARCT emission limits and includes additional combustion equipment that is currently not regulated under other Regulation XI combustion rules. PAR 1147 also updates compliance schedules with interim emission limits as well as provisions for monitoring, reporting, recordkeeping, and exemptions from specific provisions.

NOTICE IS FURTHER GIVEN that Proposed Amended Rule 1147 will be submitted to the California Air Resources Board and the United States Environmental Protection Agency for inclusion into the State Implementation Plan.

NOTICE IS FURTHER GIVEN that the Proposed Amended Rule 1147 implements Sections 110, 172, and 182(e) of the Clean Air Act.

NOTICE IS FURTHER GIVEN that a written analysis pursuant to Health and Safety Code Section 40727.2 has been prepared that identifies all existing federal air pollution control requirements, all South Coast AQMD existing and proposed rules and regulations, and all pollution control requirements and guidelines that apply to the same equipment or source type as the rule proposed for adoption.

NOTICE IS FURTHER GIVEN that pursuant to the California Environmental Quality Act (CEQA) Guidelines Sections 15002(k) and 15061, the proposed project is exempt from CEQA pursuant to CEQA Guidelines Section 15061(b)(3). A Notice of Exemption will be prepared pursuant to CEQA Guidelines Section 15062, and if the proposed project is approved, the Notice of Exemption will be filed for posting with the State Clearinghouse of the Governor's Office of Planning and Research, and with the county clerks of Los Angeles, Orange, Riverside, and San Bernardino Counties.
